  - Hosting regattas

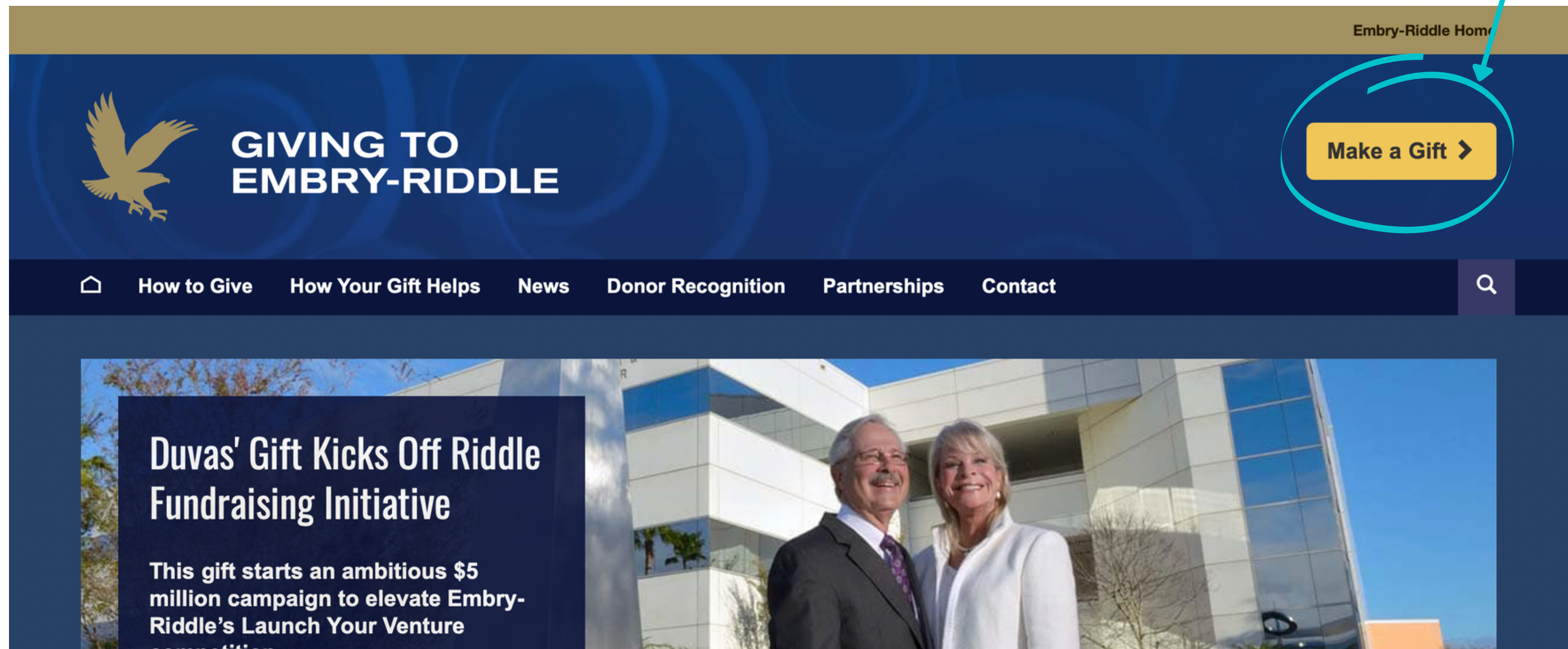
